#### *Program Summary*

Cybercrime is now a part of virtually every criminal investigation and prosecution. Digital devices (computers, laptops, tablets, and cellular telephones) are increasingly being used to facilitate the commission of criminal offenses across the globe. Both investigators and prosecutors often see obtaining and using digital evidence as a daunting task. The goal of this conference is to simplify the preservation, acquisition, and authentication of digital evidence from the onset of an investigation through trial by providing a basic introduction to cybercrime. The program will also cover how to obtain digital evidence, including data stored on the cloud; with third parties; and on electronic devices. The program will conclude with a discussion on how to authenticate and present digital evidence in court, and the legal issues surrounding expert testimony.

### *Who Is the Faculty?*

**DAG Joseph D. Remy** serves in the New Jersey Department of Law and Public Safety, Division of Criminal Justice. DAG Remy drafts legislative proposals and investigates and prosecutes criminal offenses involving child exploitation; including human trafficking, luring, and child pornography and cybercrime; including bank fraud, identity theft, network intrusions, and malware. Prior to joining the Division, DAG Remy served as an Assistant District Attorney in the New York County Manhattan District Attorney's Office from 2009 to 2016 and as a criminal defense attorney at the Law Office of Edward T. McCormack, Esq. from 2008 to 2009. During his time as an Assistant District Attorney, DAG Remy was assigned to Trial Bureau 50, where he investigated, prosecuted, and tried offenses ranging from simple assault to complex robbery cases. DAG Remy also investigated and prosecuted computer source code theft, computer hacking, and identity theft rings. DAG Remy has received awards from the United States Department of Homeland Security and New Jersey Transit Police for his work. While working with various law enforcement agencies including Amtrak Police, NJ Transit Police, NYPD, the Port Authority Police Department, Homeland Security Investigations and the US Secret Service, DAG Remy completed numerous training programs offered by the National Computer Forensics Institute, the National White Collar Crime Center, FBI Virtual Academy, and INTERPOL. DAG Remy holds a B.A. in History and American Studies, a minor in English Literature, and a secondary education teaching certification from the State University at New York College at Geneseo, and a Juris Doctor from Pace University School of Law.

**DAG Alyssa Eve Bloom** serves in the New Jersey Division of Criminal Justice Financial and Computer Crimes Bureau, where she has prosecuted and tried cases involving child exploitation, human trafficking, cyber fraud, bank fraud, securities fraud and identity theft. DAG Bloom also handles forfeiture actions for the State, including the forfeiture of cryptocurrency. Prior to joining DCJ, DAG Bloom worked in the Division of Alcoholic Beverage Control, prosecuting violations of the Alcoholic Beverage Control Act. DAG Bloom holds a Bachelor of Science in Finance from Bentley University, where she graduated Summa Cum Laude, and a Juris Doctor from Albany Law School, where she graduated Magna Cum Laude.

**DAG Lilianne Daniel** serves in the Division of Criminal Justice's Computer Analysis and Technology Unit within the Financial & Computer Crimes Bureau. While in CATU, she has prosecuted and tried cases involving cyber fraud, online harassment, hacking, and child exploitation, including cases from the large-scale takedowns Operation Watchdog, Operation Ever Vigilant, Operation Predator Alert, Operation Safeguard, and Operation Safety Net. She has received training on EnCase Computer Forensics and attended conferences on cybersecurity, counterterrorism and cybercrimes. Prior to joining CATU, DAG Daniel was assigned to the Specialized Crimes Bureau, where she prosecuted crimes involving the Motor Vehicle Commission and the Department of Labor. She also served on mobility assignment as an Assistant Counsel in the Governor's Office from May 2017 through January 2018, acting as a liaison with State criminal justice agencies and reviewing applications for executive clemency. DAG Daniel received her bachelor's degree *magna cum laude* from The College of New Jersey and her law degree from Seton Hall University School of Law. She was a law clerk in the 2011-2012 court term for the Honorable Stephen B. Rubin, J.S.C., in Hunterdon County (retired).

**DAG Thomas T. Huynh** serves in the New Jersey Division of Criminal Justice's Financial & Computer Crimes Bureau, where he works on cybercrime matters involving network intrusions, SPAM attacks and identity theft and child exploitation cases. Before joining the Division, DAG Huynh clerked for Presiding Judge Jose L. Fuentes of the New Jersey Appellate Division, worked as a student attorney in Seton Hall University's Juvenile Justice Clinic, and interned in the chambers of Third Circuit Judge Patty Shwartz and District Court of New Jersey Judge Tonianne Bongiovanni. DAG Huynh holds a B.A. in International Affairs from the George Washington University, an M.A. in History from the State University of New York at Binghamton, and a J.D. with a concentration in Intellectual Property from Seton Hall University School of Law.
