Electronic Evidence from PDAs and Cell Phones

June 6, 2007

This seminar will address the forensic, practical and legal issues that arise with respect to electronic information stored on PDAs and Cell Phones. Among the topics will be forensic issues relating to digital intercepts and obtaining cell phone and PDA data and federal and state law with respect to obtaining such data.

Who is the faculty?

John E. King, an Assistant General Counsel with the FBI, is currently assigned to the Science and Technology Law Unit, where he provides counsel to the Digital Evidence Section (DES), Operational Technology Division (OTD). As counsel to DES he is responsible for providing legal advise to the Computer Analysis Response Team (CART), Data Intercept Technology Unit (DITU), the Regional Computer Forensic Laboratory's National Program Office (RCFL NPO), Cryptologic and Electronic Analysis Unit (CEAU), Forensic Audio/Video and Image Analysis Unit (FAVIAU), and the Forensic Support Unit (FSU).

SSA Brad Morrison, a Supervisory Special Agent with the FBI's Operational Technology Division, manages the Cryptologic and Electronic Analysis Unit's Hardware Exploitation Group, which among other things, has responsibility for the forensic analysis of non-personal computer electronic devices and components, such as cellular telephones, PDAs, and global positioning systems. Mr. Morrison oversees the development of forensic standards and practices, tools, and training support and assists the FBI Computer Analysis Response Team (CART) and Regional Computer Forensic Laboratory National Program Offices in the implementation of the cellular telephone and PDA programs to the field.

SDAG Mark Eliades, is a Supervising Deputy Attorney General within the Gangs & Organized Bureau of the New Jersey Division of Criminal Justice, serves as the Attorney General's Counsel on Wiretapping & Electronic Surveillance issues and is the liaison with the Administrative Office of the Courts on those issues. SDAG Eliades serves is an Adjunct Faculty member of the National White Collar Crime Center.

Who should attend ?

Attorneys, law enforcement officers and para professionals handling criminal investigations involving access to or obtaining electronic evidence from PDAs or Cell Phones will benefit from this important program.
