Program Summary

The course will offer an overview of the court rule based discovery obligations, Brady/Giglio issues in discovery and admissibility vs discoverability of Brady/Giglio materials.

Eligibility

This program is mandatory for new assistant prosecutors and Division of Criminal Justice deputies hired after October 2019 who have been selected to attend by each county prosecutor's office and the Division of Criminal Justice. Other assistant prosecutors and Division of Criminal Justice deputies are welcome to register.

Faculty

DAG Sara M. Quigley is Acting Counsel to the Director of the Division of Criminal Justice in the Department of Law and Public Safety, where she works on policy, directives, and guidelines. She also serves on various Commissions, Committees, and Working Groups. DAG Quigley is also the Division's Legislative Liaison and advocates for the Division's position on legislative matters. Prior to becoming Acting Counsel to the Director, DAG Quigley served as Special Assistant to the Director, and was a DAG in the Appellate Bureau, where she argued before the Appellate Division and the Supreme Court and provided trial assistance to Deputy Attorneys General in the Division's trial bureaus. DAG Quigley also worked for the State Legislature in the Assembly Majority Office prior to attending Rutgers Law School. DAG Quigley clerked for the Honorable Michele M. Fox, J.S.C., Superior Court, Criminal Division, in Camden County. She also holds a B.A. in Business and Finance and Government and Law from Lafayette College.

DAG Heather Hausleben serves in the Gangs and Organized Crimes Bureau of the Division of Criminal Justice. The Bureau handles cases involving racketeering, distribution of controlled dangerous substances, weapons offenses, human trafficking, and contraband smuggling into

correctional facilities. Heather was a law clerk for Camden County Superior Court Judge Samuel Natal. She is a graduate of the University of South Florida and Seton Hall Law School.

DAG Daniel Finkelstein works on criminal appeals in the Division of Criminal Justice, Appellate Bureau. He frequently appears before the Appellate Division on a range of criminal issues. Before joining the Attorney General's Office, DAG Finkelstein served as a law clerk to the Honorable Faustino J. Fernandez-Vina of the Supreme Court of New Jersey and, before that, as a law clerk to the Honorable Louis S. Sceusi of the Superior Court of New Jersey, Civil Part. DAG Finkelstein graduated from the Benjamin N. Cardozo School of Law and, while at Cardozo, served as an Alexander Fellow to the Honorable Patty Shwartz of the United States Court of Appeals for the Third Circuit. DAG Finkelstein received a B.A. from Rutgers University- New Brunswick.
